I understand these risks, hazards, and dangers include without limitation:

- Water hazards associated with boating, fishing, and wading on Cedar Creek Reservoir
- Encounters with wildlife, fish, insects, or any outdoor creatures
- Extreme temperatures (hot and cold)
- Sunburn/frostbite/dehydration
- Inclement weather conditions
- Unavailability of immediate medical attention in the wilderness in case of injury
- Falling in/out or on/off of the boat or dock
- Injury or death from fish and the bones/fins that associate with them

I understand the risks, hazards, and dangers of fishing and have had the opportunity to discuss them with a <u>LGF</u> <u>Guide Service</u> representative. I understand that these activities may require walking, standing, balancing, or any other types of physical exercise. To the best of my knowledge, I, the client, have no physical restrictions which would prohibit my participation in my activity offered by <u>LGF Guide Service</u>. My participation in these activities is purely voluntary, and I elect to participate despite the risks. I am voluntarily using the services of <u>LGF Guide Service</u> and with full knowledge of the risks, hazards, and dangers associated with the activities booked. I hereby accept any and all risks of injury, illness, disease, death, physical or mental damage to myself, property or spectators or other third parties.

**LIFE JACKETS:** I acknowledge <u>LGF Guide Service</u> will provide life jackets in the boat for me and any minor accompanying me. We are advised to wear it but failure to do so is at my/our own risk.

**CLEANING OF FISH:** <u>LGF Guide Service</u> will not be held responsible for any bones, fins, or other fish remains that accidentally get left behind during cleaning. I, the client, am responsible for keeping meat fresh once the trip has concluded and will not hold LGF Guide Service responsible for any injury, illness, or death involving fish fillets or whole fish.

RELEASE AND ACKNOWLEDGEMENT OF RISKS: I knowingly and intentionally waive and release, indemnify and hold harmless LGF Guide Service, their guides, or any representative or volunteer from and against any claims or lawsuits. By signing this Agreement, I, as myself, or as a parent/guardian of any accompanying minor, unconditionally release and hold harmless LGF Guide Service and/or their representatives against and for all liability, cost, expenses, claims and damage to property or both, in any manner arising or resulting from, caused by, connected with or related to the participation in any activity or service offered by LGF Guide Service, regardless of how, where, or when such injury, illness, damage, or death occurs even if caused by the negligence of the guide, volunteer, or any LGF Guide Service representative, or due to conditions, defects in the vessel, equipment or activities.
